Do I need an interface?

Any Microsoft or PDF document can be uploaded to the system for eDocSignature.™ Additionally, eDocSignature™ is integrated into eDOC's ProDOC Forms™ and ProDOC Packages™ solutions.

What happens to the document after signing?

For the member, at the completion of signing your member is presented with an option to save the document for their personal records. If your credit union utilizes eDOC's Member Document Portal, members can retrieve a copy from the portal 24/7.

For the credit union, the completed document is automatically stored into the 2020DOC®, or or idocVAULT™ image store.

Does eDocSignature have mobile capability?

Yes. Documents can be signed from any Apple® iPhone® or iPad®, RIM® BlackBerry®, Google® Android™, Windows Mobile® or mobile device with internet connection.

Is the credit union notified once the documents have been signed?

Yes. All relevant parties, including the credit union and any signees, are notified via email once the signing of the document is complete.

Do I need hardware?

No. Your credit union, your members and other signees do not need any additional hardware beyond what is used to connect to the internet.

Do I have to install software?

No. There is no software installation or download required to utilize eDocSignature™.
