This specific Monthly Monitor Recap covers programming changes implemented during the month of July.

- Create an option for credit unions to choose whether they would like to include certificate renewals in open/closed dashboard
- Added ability to change names of trackers
- Enhancements to settlement reports LPANTX2 and LPANTX3
- Add PDF and Excel to dashboards on MNAUDT menu
- Enhancements to the online and mobile loan application
- Create an analytical dashboard to determine how loan payments are flowing through the system
- Transaction Date Low/Transaction Date High need to be changed from MMDDYY to MMDDCCYY on investment report
- Expand sort capabilities for Misc. Secured Funds and Uncollected Funds History inquiries

- Change the HB loan underwriting email config to send the email when a new HB loan app is added to LNAP

- Update Credit Card Maintenance Screen to display all cards

- Added the day of the week to the front end screen which only displayed the date to use for posting ACH
- Added display of MICR and RTN to the phone operator history screen

- Updated the SSO to MyVirtual Strongbox to pass the actual account number to identify the member that is signing in
- Eliminated error with member loan apps in Its Me 247 for non-member apps with comments if the member presses F5 on the confirmation screen
- Modified the About You page in the loan app so that when a member SSOs in from online banking, the loan office dropdown is populated correctly
- Updated the direct mail posting to properly show the account information in the 1st entry sequence
- Updated the Xtend Shared Branch Receipt to display as 'SB-xxx' to indicate that it is a shared branching transaction
- Updated the annual account service charge fee to not charge if the account was opened in the current year
- Notice trackers are now displaying notice titles properly, and eNotice trackers no longer have masked data
- Added correct key fields to record when adding new loan application in It's Me 247 to prevent duplicates
- Updated the drop down for accounts in the It's Me 247 download page to properly display all membership suffixes.
- Updated ACH to look the loan review date if configured before processing an ACH check transaction from an LOC loan
- Adjusted the timing in nightly batch maintenance timing to assure all records are accounted for
- Eliminated message waits for indirect loan applications with employment information.

- Corrected the delinquency notice amount to avoid adding the escrow payment in error when partial escrow payment is used
- Corrected the password security check when user is forced to change their password in MNMAST #8
- Eliminated creation of unique data area when accessing the trial balance select information through MNRPTB #1 or MN5300, #22
- Eliminated bad data in the COOP Shared Branching Investment Only Inquiry screen
- Updated CUSC and FSCC log programs to use SQL to clear log files to prevent file lock errors when both programs are trying to file at the same time
- Mortgage Statement Clients Only Corrected year to date totals for mortgage accounts with account adjustments in January and February

### **EFT Modifications**

- Co-Op Mandate Update to conform to industry standards and ensure correct passing of EMV data throughout payments system this affects COOP clients only.
- Temporary adjusted vendor PIN Transactions to capture the Name and Address of the Merchant/ATM Location.
- Updated the service program to correctly calculate the surcharge on the US Dollar currency amount when posting transactions
- Updated the incremental authorization program to send authorization ID in reply
