

The CU*BASE Monthly Monitor Recap is designed to keep you informed on an ongoing basis of feature improvements, vendor enhancements, and other miscellaneous changes to CU*BASE and our other core software products. This specific Monthly Monitor Recap covers programming changes implemented during the month of April.

Modifications

- 46560 Updated the dividend quoter to move past end of year when set up with an 18-month term and Annual Dividend Frequency.
- 47639 Updated to allow Geo-location to continue location checks on a soft return error.
- 47678 Eliminated error received when entering with Fee Waivers Dashboard.
- 47514 Resolved error from OTB AFTs when frequency is Semi-Monthly.
- 46486 Modified "Change Confirmation" text within Tool #506 – Member Rate Maintenance.
- 47136 Added functionality to access A/P history Maintenance when no history exists. This will allow the addition of records if necessary.
- 47780 Added a check to clear CU user name required flags when members select challenge questions and properly populate login for some instances during the login process.
- 47802 Changed the program for creation of a new year to rebuild indexes to eliminate error messages.
- 46516 Max amount field in the credit report pull program has been expanded.
- 47010 Updated the Insurance Expiration Report to include zero balance loans.
- 47486 Adjustment to COOP Shared Branching FSCC reversals to avoid failing.
- 47872 Changed user response codes on password disable to alert members that they can reset their password without contacting the credit union when challenge answers exist.
- 45905 Updated report settings to use entire workstation name to save and retrieve.
- 47788 Updated the Daily OTB Credit Card Payment File to sort by OTB Code.

- 47784 Updated the credit card batch maintenance process to stop clearing BIN information in credit card records and flood BIN data where the fields have already been cleared.
