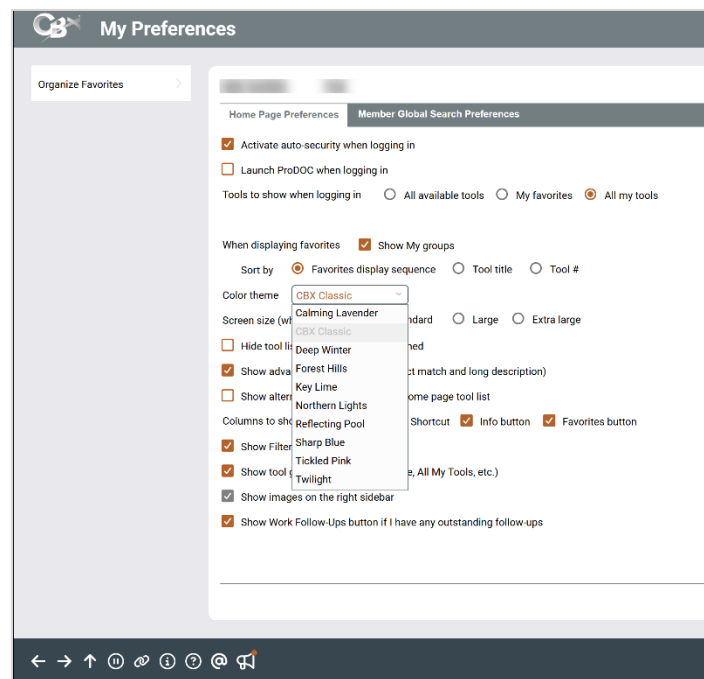

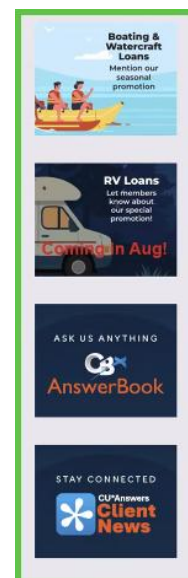
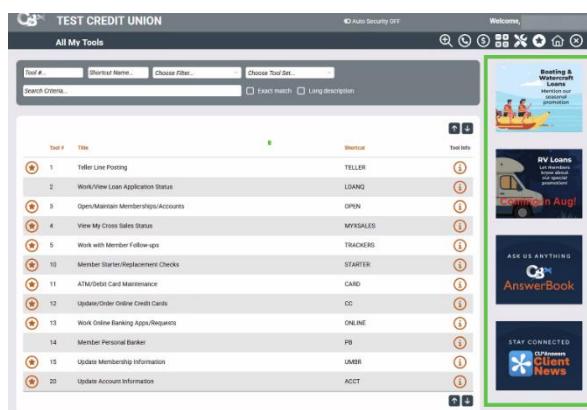


CU-Defined Images Now Available on the CBX Home Page

Employee Security Updates to the CBX LOS

Project Number: 67343

This release will deploy enhancements to our employee security settings for the CBX LOS. These enhancements will allow you to control which employees are able to create or access loan applications for existing members, as well as which employees are able to book/create loan accounts.

- NOTE: First review your Employee Type Codes configuration for insiders (**Tool #517**) as this may impact work though **Tool #2**. Remember **Tool #517** is used for all employee IDs.
- Tool #327 Employee Security** overrides **Tool #517** and will now provide more controls on **Tool #2**, **Tool #53**, and **Tool #394** as described in greater detail below.
 - For an employee to be authorized to create/access loan applications for existing members, the *Allow Account Inquiry* & *Allow Account Maintenance* checkboxes are both required to be checked.
 - For an employee to be able to book/create a new loan, the bottom check box *Allow Posting to Account* is required to be checked. This checkbox works together with the 'loan

underwriting' special security feature, meaning both boxes would need to be checked for an employee to be able to book/create a loan account.

Please keep in mind: the Allow Account Inquiry and Allow Account Maintenance checkbox controls will only allow/prevent employees from handling existing member loan applications. These settings do not apply towards non-member loan applications.

We expanded the VMBPACTAUD (MemberPass Activity Audit File) table to include the account base associated with the authentication request. This allows clients to easily identify the account that was accessed when the Authenticate Me feature was used.

☒ **New Record Added to Existing Automated Query Audit Report (PRUNAR)**

Now credit unions will see a new record on the existing Automated Query Audit Report (PRUNAR) when a Query is not run during automated query processing due to an error. This entry will provide details on the query and why it did not run. The report is placed in the DAILYxx OUTQ for review. For a sample, refer to the Automated Reports and Queries booklet, available on the CBX reference page.

Database Changes

Running Your Custom Queries

If a file listed below is included in any of your custom reports or inquiries, you must refresh the Query definition, **or your Query MAY NO LONGER RUN:**

1. In **Tool #100 CU*BASE Report Builder (Query)**, choose **2=Change** and enter your Query name, then use Enter to proceed
2. Select **Choose Files**
3. Use Enter  to move through these screens until you're back to the **Report Builder - Main Menu**
4. Use **Exit** 
5. Select ☒ **Save query definition** and Run **Interactively** then use Enter 

NOTE: If the field changes from a numeric to an alpha-numeric field, you will need to add 'single quotes' around the Selection Criteria.

Updating Your Automated Queries

If you ever remove or add a file to a Query definition of a Query that you have automated, your Query **MAY NO LONGER RUN** unless you also **update the Query automation configuration** as follows:

1. Access **Tool #758 Report Automation – Custom Rpts/Files**
2. Select the Query and use **Edit**
3. Make the necessary changes and use **Add/Update** to save

NOTE: You do not need to do this if all you do is tweak a selection parameter such as modifying a date.

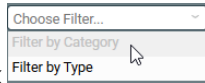
