# **Pick #1:** <u>When a member submits an online loan application, I want my loan</u> <u>department to get a notification.</u>

Starting with the 15.1 release, you can configure CU\*BASE so that your loan department is immediately notified when a member submits a new loan application in online or mobile banking. By using a distribution list, you can easily change the list of individuals who are notified.

#### **Pick #2:** <u>My state requires that information on the spouse be included on a loan</u> <u>application. I want to ensure I get this when a member applies online.</u>

The 15.1 release includes a large number of updates to the online loan application, one of which relates to community property. Your credit union can now activate a feature in CU\*BASE that will require applicants who indicate that they are married to fill in the fields on the "Information about Your Spouse" page of the updated online loan application.

## **Pick #3:** <u>I want to learn more about the TILA/RESPA mortgage loan estimate</u> and closing disclosure forms.

While the deadline for mortgage lenders to move to the new disclosures isn't until August 1, 2015, we're implementing the disclosure screens in the 15.1 release. These new mortgage forms are designed to make information easier to input, save, and print. They also make it easier for members to locate important loan information.

#### **Pick #4:** <u>When I send an external wire transfer, I want to first check if there</u> were any recent email, phone number, or address changes made on the account.

The Red Flag feature allows you to check an account for recent personal information changes, including email, phone number, and address changes. You can now activate this feature for external wire transfers.
