Fixes

- Corrected an error that could come up when removing a user from all groups for a given Credit Union via Member Management
- Corrected faulty email validation when creating a new user. Value entered must now look like a valid email address
- Updated the add member process so that a user group must be selected in order to add the user
- Corrected a bug where selecting a different credit union from the credit union selector would not always change the selected credit union
- Corrected an issue where branches were not being displayed in the branch selector if there were multiple branches with the same name
- Corrected an issue where names with apostrophes (e.g. O'Connell) would not display correctly on the My Account, Edit Account, and Edit Member pages
- Corrected an issue where the "Everything Alert" was not being delivered when it should have been
- Corrected an issue where validation errors displayed in a query dialog did not display the close dialog button properly
- Corrected javascript error when loading the alerts page

Updates

- Updated the "Mini Graphs" on the trends page to display a more useful default set of trends
- Password Reset email styling updated for consistent styling with other site generated email messages
- Updated site for aesthetic and usability considerations on a wide variety mobile devices
- Disabled the save button when editing a member until a change has been made to the users information
- Updated CU*Answers banner ad feature feed loading so that it would not delay the loading of the page that it was displayed on

- Password reset no longer requires the user to enter the first and last for the account, only the email address
- Removed the "Guest" groups. Users will now be added explicitly via the Member Management page.
- CSR accounts will no longer be visible on the Member Management pages unless the logged in user has CSR access or higher
- Added "All Time" to the Trend graph date range selector
- Add/Edit member page now displays a prominent message on success
- Alerts now display selected branches as a tooltip under the house icon under "My Saved Alerts"
- Alerts now display specified CC addresses as a tooltip under the house envelope under "My Saved Alerts"
- Context sensitive help has been added to various areas throughout the site. The help information is available under the "i" icons
- Added placeholders for the forthcoming trends data categories "Cash Data", "Delinquency Data", and "In-process Data"
- Added instructional page explaining how to add alerts@mycutoday.com to the address book/safe list for various email clients
- Added Last Login and Last Failed Login information to the Edit Member and Edit Account pages
- Added the online banking ID to the credit unions displayed in the credit union selector

Backend

- Updated log rotate scripts to rotate the My Cu Today activity logs
- Import result email updated to more clearly indicate if a problem has occurred during the import process
- Stale data check updated to eliminate excess noise on branches for which we have never received any data
- Added logging of which trends have been viewed
- Added Usage Stats page under Site Management to report on site usage data
