How to order

The Cooperative Campaign will be available to order on store.cuanswers.com under the Marketing shop category.



Once you find the Cooperative Campaign product, click on "Select options". From there you can view all 12 monthly campaigns where you will be able to pick and choose campaigns to add to your cart.

For example, if you want to order the January Campaign, you will have to order no later than December 15. After December 15, the campaign will no longer be available to purchase.
